# MINUTES OF THE REGULAR BOARD MEETING DATED October 12, 2020 MEETING held at TRAC Multipurpose room

Chairperson Mindi Schmitz called the meeting to order at 4:05pm.

Mike Soulis made a motion to approve the September 14, 2020 minutes after correction: change from all approved to Mike Landscoot voted against Remote Work Policy and approve the September 14, 2020 Public Hearing minutes. Mark Ukestad seconded. All approved.

Mark Ukestad made a motion to approve the Financial Report. Mike Landscoot seconded. All approved.

#### **OLD BUSINESS:**

Board Development - Strategic Plan Process: Jodi will meet with the board following the meeting today for follow-up.

**COVID-19:** Doug Hogan stated since Stutsman County has changed from yellow to green the maximum capacity has been increased from 250 to 500 and we are able to start women's volleyball league. The Economic Resiliency Grant has given us \$15k in reimbursements, purchased 3 electrostatic sprayers and will be installing touchless plumbing fixtures in different areas. The Cares Act reimbursed \$35K in expenses already incurred.

Cart Storage - Winter Rates: On agenda from last month for more discussion.

## **NEW BUSINESS:**

**Hillcrest Golf Course Ponds:** Mike Landscoot requested this be on the agenda as he would like to see the ponds dredged and clean out the cattails. The drainage from pond to pond also needs to be cleaned out. Discussion on whether to get bids or something we can do ourselves.

**Vandalism in Parks:** Discussed the continued vandalism in parks. Bathrooms normally close mid to late October.

#### **REPORTS**:

Written reports were submitted.

Doug Hogan reported the Sensory Garden is receiving Freedom Resource Accessibility Award. The ceremony will be held virtually but will take a picture at the Sensory Garden with Board of Commissioners and Sensory Garden Committee on Friday, October 16<sup>th</sup> at 3:30pm.

Bob Schuchard added that insulation was added when completing the WSB outside wall project. Bunker floor is being refinished and getting 2<sup>nd</sup> coat on ballroom floor and then will refinish floor in Nierling Room. Discussion on wanting 5 FT employees and seasonal employees only May-Oct.

John Ruff women's volleyball league begins tonight; saw a lot of new golfers this year, more income from green fees, rentals and memberships than budgeted – looking to close the course soon.

Amy Walters – Need lifeguards, may need to adjust pool hours, daily visit numbers are up, foundation poured for features and bath house for splash pad. Features will arrive next week

John Miller – Everything is in report.

Junior Kautz – Highlighted from his report that he has received \$2400 in anonymous donations to purchase 34 pairs of skates.

Next meeting is scheduled for November 9, 2020.
