Chairman Mindi Schmitz called the meeting to order at 4:00pm.

<u>Director Search Process:</u> Mindi Schmitz reported she has gathered information from other park districts and the NDRPA to guide the search process and prepared a timeline document from this research.

- September Establish search committee: Mindi Schmitz Jamestown Parks & Recreation Board Chairperson, Sarah Helleckson - City of Jamestown Administrator, Rob Lech – Jamestown Public School Superintendent, Searle Swedlund – Jamestown Tourism Director and Jim Speidel – Jamestown Parks & Recreation Parks Foreman. This committee will review/update the current job description and recommend a salary range.
- October Board of Commissioners review/approve job description & salary range. Post position NDRPA, National Parks & Rec Association, ND Job Service, Indeed and other. Search committee will create a rubric based on skill and attributes outlined in job description. Committee to create interview questions.
- November Committee to select candidates to interview and invitations made to selected candidates.
- December Committee to interview candidates December 1-3 (virtually or in person), conduct 2nd interviews if necessary. Mindi complete reference checks, offer position, discuss salary/benefits and start date.

Discussion on the proposed search process. Mark Ukestad made a motion to approve the Director Search presented with the following amendments: In November, a meet and greet with commissioners, employees and stakeholders for the selected interview candidates. In December, commissioners receive candidate recommendation for approval. Ron Olson seconded. All approved
