Chairperson Mindi Schmitz called the meeting to order at 4:00pm.

Welcomed guests.

Public communication:

Paul Belzer wanted to know why kids can't get into rink on snow days. Would like to create a working group to have indoor rinks available during storm days. Agenda item for next month

Tim Gutschmidt is interested in the round balls that are part of Nickeus Park Bridge when the bridge replacement. Would like to use them as yard art. Also, interested in the curl railing.

NEW BUSINESS:

Agreement with Interstate Engineering to serve as Owners Rep for McElroy Park Field Renovation: Baseball project moving forward need to have an agreement with Interstate Engineering to serve as Owners Rep for the project. This will be similar to agreement we had with Interstate Engineering during TRAC construction. With the \$920,000 grant, funds are available to cover fees. Mindi Schmitz made a motion to enter into an agreement with Interstate Engineering to provide engineering and owner's representative services to Jamestown Parks and Recreation for the McElroy Park Field Renovation Project. Mike Soulis seconded. All approved.

Joint Powers Agreement (JPA) with City of Jamestown for Park Bridges: There is no historical data of who owns the bridges in Klaus, Nickeus and McElroy Parks. Bridges are on both City of Jamestown and Jamestown Parks & Recreation property. The Joint Powers Agreement with the City of Jamestown would determine joint ownership of the bridges. Regular & routine maintenance such as snow removal and painting will be our responsibility. Any significant repairs would need mutual agreement of both parties. Mike Soulis made a motion to approve the Joint Powers Agreement with the City of Jamestown to enter into mutual ownership of the pedestrian bridges at McElroy, Nickeus and Klaus Parks. Ron Olson seconded. All approved.

Beverage/Pop Contract: Our current 5-year contract with Pepsi expires February 28, 2023. Mike Landscoot made a motion to distribute the Request for Proposal for vending of beverages and form a sub-committee consisting of Amy Walters, Bonnie Ukestad and John Ruff to review all proposals and develop a recommendation for board approval. Mike Soulis seconded. All approved.
