MINUTES OF THE SPECIAL BOARD MEETING DATED August 11, 2023

Chairman Mindi Schmitz called the meeting to order at 7:00am.

Contract with Mammoth Sports Construction: Abbagail Geroux – Dalsted & Ryan, P.C. led conversation regarding the contract with Mammoth Sports Construction. After the contract is signed there will be an amendment for the amount and timeline. Abby wanted JPRD to be aware:

- The estimate of 3.8 million does not include engineering so we will have extra costs associated with engineering.
- There will be cost of work project plus a 4% fee.
- We will also need to get builders' risk insurance which will be an additional cost. It will be cheaper to go through Mammoth Sports Construction for the builders' risk insurance than through our own insurance.
- If there is any change in price or completion date there will need to be board approval.

Board members did not want to go into executive session.

Mark Ukestad made a motion to enter contract with Mammoth Sports Construction and authorized Amy Walters, Executive Director to sign contract. Mike Landscoot seconded. All approved.

Award Bid for Rotary Mower: Bids were opened for the rotary mower on July 26th. One bid was received and it met the RFP requirements. MTI \$79,778.18. Mike Landscoot motioned to accept the bid from MTI and authorize Amy Walters and Bonnie Ukestad to use local lender. Mark Ukestad seconded. All approved.

Set Budget Hearing Date/Time: Budget hearing date and time needs to be submitted to County Auditor. Our next board meeting is September 11th. Discussion on what time. Mike Landscoot motioned to have the Budget Hearing at 5:00pm on Monday, September 11th at TRAC. Mark Ukestad seconded. All approved.

Mark Ukestad motioned to adjourn, Chairperson Mindi Schmitz adjourned meeting at 7:31am.
